



# Sedgwick USD 439 Learning Options

At this time, USD 439 is planning for Option 1, Paths 1 & 2, for the beginning of the 2020-2021 school year. Parents will be provided a choice during enrollment for on-site learning or remote learning. Please understand that we do not have all of the answers that you may need to make a final decision, but your choice will help in preparations for the start of the school year. All families will need to complete the USD 439 enrollment process.

## Option 1

### Path 1 – On-site Learning

- This plan represents a return to the school campus and the classroom where students will interact directly, with safety precautions, with their teacher(s) and classmates.
- Teachers will provide in-person instruction, 5 days a week.
- Instruction in core subjects and electives.
- Elementary students stay with same group of students for the majority of the day.
- Accommodations and support services provided (emotional, social, special education, intervention support, etc.).
- Transportation provided for eligible students.
- School meals available at all school locations.
- Eligible to participate in athletics (pending KSHSAA and USD 439 BOE requirements).
- Approved extracurricular activities.
- District technology provided to all students grades K – 12.
- Strengthened disinfecting and preventive health measures will be in place.
- Masks required for all USD 439 students and staff.
- Social distancing will be followed when possible.
- All students will be assessed for symptoms of COVID-19 during daily temperature checks.

## Option 1

### Path 2 – Remote Learning

- Online learning option for students who are unable to return to school building.
- Once enrolled in Path 2, changes can only be made with administrator approval.
- Students will be assessed on the same standards and competencies as on-site students.
- Students must be LIVE when scheduled for instructional times (based on the information from the teacher). Connection can be through interactive video conferencing.
- Kansas state attendance/truancy policies will be followed.
- All assignments must be completed as required by teachers.
- Students must maintain a daily log of activities, equal to a school day, signed by the student and parent and submitted weekly to the school district.
- Accommodations and support services provided (emotional, social, special education, intervention support, etc.).
- May not be eligible to participate in athletics or activities (pending state guidance).
- Meals will be provided from the school. Families may be able to purchase or pick up meals at designated locations (pending USDA approval).
- District technology provided when applicable to each student grades K – 12.
- Internet access required. USD 439 may help locate internet access connections.

## Contingency A – Hybrid Learning

- This plan would be activated by the District if concerns are high and additional health and safety measures are needed.
- Students will be divided into two groups – A and B.
  - Group A:
    - On-site instruction on Monday and Tuesday; remote learning on Wednesday, Thursday, and Friday.
  - Group B:
    - On-site instruction on Thursday and Friday; remote learning on Monday, Tuesday, and Wednesday.
- On remote days, students must maintain a daily log of activities, equal to a school day, signed by the student and parent and submitted weekly to the school district.
- Wednesdays: all students will participate in remote learning and teachers will do individual checks on students.
- Buildings will be deep cleaned on Wednesdays and on weekends.
- Accommodations and support services provided (emotional, social, special education, intervention support, etc.).
- Transportation provided for eligible students on school days.
- School meals available when students are at school. Families will be able to pick up meals at designated locations (pending USDA approval) on days away from school.
- May be eligible to participate in athletics or activities (pending state guidance).
- District technology provided to each student grades K – 12.
- Strengthened disinfecting and preventive health measures will be in place.
- Internet access required. USD 439 may help locate internet access connections.

\* The learning options and school calendars are planned based on current public health recommendations and may be subject to change based on public health mandates.

\* Contingency A and Contingency B would be activated by the District for our on-site learners if community health concerns are high.

## Contingency B – All Distance Learning

- This plan would be activated by the District if schools must close due to COVID-19 restrictions.
- Online learning for all students, grades K-12.
- Students will be assessed on the Kansas standards and competencies.
- Students must be LIVE in the classroom during instructional times (based on the information from the teacher). Such connection can be through interactive video conferencing.
- Students must maintain a daily log of activities, equal to a school day, signed by the student and parent and submitted to the school district.
- Instruction in core subjects. Electives may be limited.
- Accommodations and support services provided (emotional, social, special education, intervention support, etc.).
- Meals will be provided from the school. Families may be able to purchase or pick up meals at designated locations (pending USDA approval).
- District technology provided when applicable to each student grades K – 12.
- Internet access required. USD 439 may help locate internet access connections.
